**LIABILITY RELEASE, HEREBY RELEASE, ASSUMPTION OF RISK AND ARBITRATION AGREEMENT**

**LIABILITY RELEASE** – By attending with Host "GVISIONS Photography, LLC", (hereinafter referred to as the "Workshop, Seminar, Private") I acknowledge that it is not without risk. I agree that the Host and its heirs, agents, employees, guest or assigns will not be held liable for injury, illness, accident and travel hazards by foot, air, vehicle, water craft, emergency, death or other related problem(s) arising from the Event. I also agree to hold Host and its heirs, agents, guest, employees or assigns harmless in the event I suffer personal property theft including but not limited to photography related equipment, damage, loss or the above mentioned while attending the Event.

**I HEREBY RELEASE** – discharge, and covenant not to sue GVISIONS Photography, LLC, directors, volunteers, guest and employees, any sponsors, advertisers, and if applicable, owners and lessors of premises, on which the Workshop, Seminar, Private takes place, (each considered one of the Releasees herein) from all liability, claims, demands, losses or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise; and I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement, I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save and hold harmless each of the Releasees, from any litigation's expenses, attorney fees, loss, liability, damage, or cost which may incur as a result of any such claim.

**ASSUMPTION OF RISK & FULLY UNDERSTAND** that – (a) Workshop, Seminars, Private are conducted in outdoor and indoor environments, and that accordingly I and my photography equipment may be exposed to dangers and hazards both natural and man-made; (b) Workshop, Seminar, Private activities involve risks and dangers of serious bodily injury (including permanent disability, paralysis and death), as well as risks and dangers to photography equipment; (c) these Risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in the Workshop, Seminar, Private, the condition in which the Workshop, Seminar, Private takes place, or the negligence of the Releasee names below; (d) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time. I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the Workshop, Seminar, Private.

**JURISDICTION AND ARBITRATION** – The laws of Florida govern this Agreement without regard to conflicts of law provisions. I consent to the exclusive jurisdiction of the state and federal courts sitting in the state of Florida. All unresolved disputes arising under this Agreement shall be submitted to arbitration in Florida. The arbitration shall be conducted under the rules then prevailing of the American Arbitration Association. The arbitrator's award shall be binding and may be entered as a judgment in any court of competent jurisdiction. Notwithstanding the foregoing, either party may refuse to arbitrate when the dispute is for a sum less than \$5,000.

**KNOWING AND VOLUNTARY EXECUTION** – I have read and fully understand the contents and legal ramifications of this Liability Release, Assumption of Risk and Arbitration Agreement. I understand that this is a legally binding and enforceable contract and I sign it of my own free will. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.
